Overview

This website is operated by NORD Corp B.V. Throughout the Site, the terms "we", "us" and "our" refer to NORD. If you do not like the product as hoped, you can return the product to NORD within 14 days of receipt and you will receive a refund. The product may be used, but must be returned in the original packaging. The product must be handled with care. If it is damaged, you will not receive a refund.

Enter your order number in the hashtag and add the reason for your transport after the dash. Then describe in detail in the email why you are returning your product.
